#### **About the course**

This program offers individuals the opportunity to gain a qualification and experience supporting adults within the care sector; with pathways to employment within the aged care, home care or disability services.

#### Who should enrol

Passionate and caring individuals seeking the opportunity to receive accredited training in the care sector. Applicants should possess a calm, patient nature and should be capable of operating within a team as well as with some independence.

## **Learning outcomes**

Successful completion of this course will enable you to gain a nationally accredited qualification in an industry which offers a broad range of employment opportunities.

## Attendance, study load and student support

You will be required to:

- Attend all scheduled tutorials, workshops and simulated activities including two tutorials per week (10 12 hours per week spanning 22 weeks);
- Undertake theory and practical assessment activities (up to an average 20 - 25 hours per week of the program);
- Undertake self-paced learning activities over 22 weeks of the program, including individual research in your own time (estimated at 8 - 10 hours per unit of competency for the average learner).

Details and expectations on activities will be provided in individual training plans. Student support is available prior to and at the end of each session. Scheduled support sessions will also be available.

## Work experience/placement

- Complete a minimum of 120 hours of work placement.
- Work placement will be organised as you progress through the course and could include both morning and afternoon shifts.
- Your Trainer/Assessor or WVI representative will consult with you regarding your work
  placement, options available to you and your availability. Your work placement will
  commence shortly after you reach midway in the course.
- Rosters for work placement will be developed in consultation with your industry host provider and your Trainer/Assessor will undertake skills and observation assessments at appointed intervals throughout your work placement period. You will be visited by your Trainer/Assessor throughout your work placement; your course schedule/timetable will provide additional information about visits and observation and assessments.

#### **Assessment**

Assessment will include a range of activities such as written tasks, oral questions and skills demonstration within a simulated and/or actual work environment.

N.B. Students need to be aware of, and consent to video record themselves for the purpose of gathering and submitting workplace assessment evidence relating to specific performance tasks.



### **Entry requirements**

Wesley Vocational Institute has set the following entry requirements for enrolment in this course:

- Ability to commit to the attendance and study load requirements of this course.
- Satisfactory level of language, literacy and numeracy.
- Be an Australian/New Zealand citizen, Australian Permanent Resident or Humanitarian visa holder.
- Satisfy NSW Public Health Orders and Industry Work Health and Safety requirements.
- Reliable computer and internet access.
- Willingness to complete, a volunteer 'Working with Children Check' and;
- Australian National Police Check \*\*
- Some host employers will additionally require an NDIS screening check.

\*\*Due to the duty of care requirements of service providers, individuals with disclosable court outcomes may not be given access to services for the purpose of completing their work experience – please consider this prior to enrolling. If you wish to have a confidential discussion regarding this matter, please contact our office via the details provided below.

#### Course fees
