About the course

This course is specifically designed for First Nations Peoples either looking to support their community or for those who support First Nations Peoples within the work place. The qualification reflects the role of workers who provide self-directed recovery-oriented support for people affected by mental illness and psychiatric disability. Work involves implementing community-based programs and activities focusing on mental health, mental illness and psychiatric disability. Work is undertaken in a range of community contexts such as community based non-government organisations; home based outreach; Centre-based programs; respite care; residential services, rehabilitation programs; clinical settings; or supporting people in employment. Work is carried out autonomously under the broad guidance of other practitioners and professionals.

The achieve this qualification, the candidate must have completed at least 80 hours of work detailed in the Assessment Requirements of units of competency

Who should enrol

First Nations Peoples who are passionate and supportive individuals seeking the opportunity to receive accredited training in the mental health industry. Applicants will want to gain accredited VET qualification that enables them to apply for the entry level industry positions. Applicants should be realistic about the work required to complete this course in conjunction with existing tertiary studies or work commitments and be committed to attending class, completing assessments within set time frames and attending work placement.

Applicants should possess a calm, patient nature and should be capable of operating within an environment that deals with a broad range of challenging, social, cultural and welfare related issues.

Learning outcomes

Successful completion of this course will enable you to gain a nationally accredited qualification in an industry which offers a broad range of mental health employment opportunities.

Attendance, study load and student support

You will be required to:

- Attend all scheduled online tutorials, face to face workshops and simulated activities, this
 includes a 4 hour online tutorial once every 2 weeks. Spanning 18 months. (excluding
 course breaks).
- Participate in learning activities; readings, case studies, projects, quizzes, self-paced learning and other tasks including individual research in your own time (approximately 15 hours per unit of competency for the average learner)
- Undertake theory and practical assessment activities (approximately 20-25 hours per unit of competency).
- Undertake self-paced learning activities over 18 months of the program, including individual research in your own time (estimated at 4-6 hours per unit of competency for the average learner)

Details and expectations of activities will be provided in individual training plans. Student support is available at the end of each class. Scheduled support sessions will also be available if required.

Work experience/placement

- Complete a minimum of 80 hours of compulsory work placement.
- Students will source their own work placement with assistance from Wesley Vocational Institute through class activities and administration support
- Students are encouraged to complete as many hours as host employers will provide.
- Host employers must be approved by the trainer/assessor and hours can be completed in a schedule that is agreed upon between the student and host employer, provided 80 hours are fully completed before the course end date.

Assessment

Assessments will include a range of activities including role plays, simulations, written tasks, oral questions, projects and recorded observations in the workplace or simulated environments.

Entry requirements

Wesley Vocational Institute has set the following entry requirements for enrolment in this course:

- Employed within the Disabilities, aged care or mental health or community services sector in relevant position.
- Proof of employment status position description and/or resume.
- Be an Australian/New Zealand citizen or Australian Permanent Resident
- NSW residency or employed by NSW employer
- Satisfactory level of English language, literacy and numeracy.
- Ability to commit to attendance and the study load for this course.
- IT literacy and reliable computer and internet access.
